**SANUWAVE, Inc. Announces Shock Wave Presentation at Wound Healing Science and Industry Meeting**

**Alpharetta, GA, January 2, 2009** – Oscar Alvarez, PhD conducted a presentation entitled, *Shock Wave Therapy*, at the 9<sup>th</sup> Annual Wound Healing: *Science and Industry* conference held December 12<sup>th</sup> through 14<sup>th</sup> in St. Thomas, U.S. Virgin Islands. The Wound Healing: *Science and Industry* conference is a three-day interdisciplinary meeting that focuses on topical issues affecting wound healing. Faculty presented from both academic and industry perspectives the emerging science of wound care. Discussion and interaction with wound healing leaders representing many disciplines, state-of-the-art developments in wound healing and technology developments were presented and discussed. SANUWAVE supported the event with an educational grant.

The *Shock Wave Therapy* presentation included a discussion of the advances in using Extracorporeal Shock Wave Technology (ESWT) as a wound healing modality. A summary of European data suggested excellent clinical results using this technology to treat open wounds including burns, diabetic foot ulcers and traumatic injuries. Recent laboratory studies indicate that the mechanisms of action surrounding shock waves make this technology compatible with wound healing by increasing microcirculation, decreasing inflammation, and stimulating cell growth and proliferation.

In the U.S., Dr. Alvarez is a principal investigator taking part in the dermaPACE® clinical trial. The dermaPACE® trial uses a specialized form of the ESWT called Pulsed Acoustic Cellular Expression (PACE™) Technology. The dermaPACE® is the first device based on this technology platform. This trial is specifically investigating the treatment of diabetic foot ulcers, a condition that if untreated can lead to costly and debilitating amputations for people with diabetes. Dr. Alvarez is the Director of the Wound Care Program and Calvary Hospital in Bronx, New York and the Associate Professor in the Department of Medicine at New York Medical College.
